# OUR VOTE IS NOT FOR SALE!

State campaign reports show that left-wing special interest groups in Washington D.C. and Oklahoma City have poured thousands and thousands of dollars into Democrat attorney Darrell Moore's campaigns.

By contrast, Republican auditor Tom Gann has refused to take funds from lobbyist-represented groups. This means rejecting thousands in campaign funds and hundreds of personal gifts customarily given to legislative incumbents.

It is unethical for lawmakers to take the personal gifts and the massive campaign donations have corrupted most office holders.
